Consignor Agreement

1. Consignor attests that they are the legal owner of all items brought in to KARMA for resale. Any items proven otherwise will be turned over to proper authorities. **Initial:**
2. Items must be current fashions, season appropriate, recently cleaned, in excellent condition. Items will be inspected and chosen while you wait. If you choose not to wait and want to leave your items for our consideration to consign, any items not selected will be donated. **Initial:**
3. The consignor will receive 40% of item's selling price minus any cleaning or repair fees. Prices are set by Karma and are competitive to other resale prices. (i.e: Poshmark, Ebay, Tradesy, etc.) All items are subject to being included in store sales. **Initial:**
4. A Cleaning/Repair fee may apply if your item is accepted but needs additional work to make it "hanger/shelf ready". This includes: washing, steaming, de-pilling, lint/pet hair removal, sewing, etc. A fee will only be applied and taken out of the consignor's earnings if the item sells. **Initial:**
5. All items selected will be on consignment for a period of 90 days. Karma reserves the right to pull any item from inventory at any time, for any reason. **If you wish to retrieve unsold items, it is your responsibility to monitor the 90 day period.** After expiration, any unclaimed inventory will be deemed abandoned and become the property of Karma. **Initial:**
6. Karma will do its best to safeguard your items, but all merchandise is left at your own risk. Karma assumes no liability for damage by customer handling or loss by theft or fire of any item consigned. **Initial:**

7. If for some reason Karma needs to return an item to you before the 90 day period is up, you will receive an email notification to pick up said item within 7 days. Thereafter the item will be deemed abandoned and become the property of Karma. **It is the consignor's responsibility to ensure they are receiving our emails** by providing an accurate email address and monitoring that account. Karma is not responsible if you don't receive or view any notification.

8. Account balance can be applied as A) store credit or B) a check with a minimum account balance of \$25. Any balance under \$25 will be valid only for store credit. **Checks must be requested within 120 days of the end of the consignment period.** After which time all monies will be forfeited and balance will be converted to store credit. Store credit will be valid for one year. **Initial:**

Things to consider before consignment:

- Items will be considered for consignment by appointment only.
- We do not take fake inventory like knock-off handbags.
- We do not take business wear, this includes skirt/jacket sets, etc.
- We do not take 'fast fashion' even if it is new with tags. This includes such retailers as Target, Walmart, Forever 21, Old Navy, Kirkland, etc.
- We do not take fur.
